5.3. Special protective actions for fire-fighters

6.2. Environmental precautions

6.3. Methods and material for containment and cleaning up

Place in a metal container approved for transportation by appropriate authorities. Clean up residue with an appropriate solvent selected by a qualified and authorized person.
